## The North Carolina Shakespeare Festival's 30 Days of June Raffle (Originally Announced as 31 Days of May Raffle) Official Rules & Prize Descriptions

**General Description:** The 30 Days of June Raffle (the "<u>Raffle</u>") to benefit the North Carolina Shakespeare Festival. The Raffle begins at 12:01 a.m. Eastern Standard Time ("<u>EST</u>") on December 20, 2013 and ends at 11:59 p.m. EST on May 31, 2014 (the "<u>Raffle Period</u>"). At the end of the Raffle Period, prize winners will be selected by random drawing from among all eligible entrants on June 1, 2014, and one winner per day will be announced for each day of June 2014, as described herein.

Sponsor: The North Carolina Shakespeare Festival, 807 W. Ward Avenue, High Point, NC 27260 (the "Sponsor").

**Eligibility**: The Raffle is offered only in North Carolina and is open only to legal residents of North Carolina, 18 years of age or older at the time of entry. Employees, as well as their immediate family members (parents, children, siblings, spouse) and others living in their same household, whether related or not, of the Sponsor or any of its representatives, agents, or affiliated entities (together, the "Released Parties"), are not eligible to enter the Raffle. The Raffle is subject to all applicable federal, state, and local laws and regulations, and is void wherever prohibited or restricted by law.

**Agreement to Official Rules**: By entering the Raffle, entrants agree to be bound by these official rules and the decisions of the Sponsor, which are final and binding in all matters related to the Raffle, the selection of the winners, and the awarding of any prize. Ward Avenue, High Point, NC 27260) during normal business hours during the Raffle Period. Raffle tickets are \$20.00 per ticket, or \$50 for a package of three tickets. One Raffle ticket entitles the purchaser to one entry into the Raffle prize drawing as described in the "Winner Selection and Prizes" section below. Raffle tickets must be purchased and received as completed entries by 11:59 PM EST on May 31, 2014. Only those entries actually received by Sponsor during the Raffle Period will be entered in the random prize drawings as set forth below. All times are measured by the Sponsor's clock. Proof of sending is not proof of receipt; screen shots or confirming e-mails will not be accepted as proof of receipt. All entries become the sole property of the Sponsor and will not be returned.
